## **BTWF TITHING POLICY**

As a Leader of Believers Temple Word Fellowship, it is important that you have not only the Heart, Spirit, and Mind of God, but that you also walk in obedience to His instructions as it pertains to your tithe, offering, and the position of being a Leader.

Leaders consist of; All Senior Elders, Ministerial Staff, Overseers, Team Leaders, Assistant Team Leaders, MOH Liaison, Deacons and Deaconesses, and the Administration Staff.

### **REVIEWING OF TITHE AND OFFERING PROCESS**

Tithing Review happens on a quarterly basis. At the end of each Quarter (March, June, September, and December) your statement will be reviewed. If the “oversight” of paying tithes on a consistent basis is not adhered to, below is the process that will go into effect. If you are a faithful tither, this process in no way will affect your position as an active Leader in ministry. Please keep in mind that adjustments are made when there is more than one income in one household and both parties are employed and functional leaders in ministry.



- 1) **MARCH** – If found that tithing is not consistent, a gentle reminder letter will be sent informing you of your commitment to God's word and to this ministry as it pertains to your monetary contribution.
  - If there has been a hardship or any type of lifestyle change that plays a factor i.e. laid off, fired, hours cut, pay decreased, additional household increase etc...please notify Administration.
  - It is not the goal to micromanage what everyone brings into the ministry
  - It plays a major factor of accountability, integrity, obedience to God etc...
  - Not the goal to have members in ministry, praying at the altar, talking over the pulpit, or operating in ministry yet they are not faithful in the capacity God has written in His Word.
- 2) **APRIL** – If no communication has been made on your part to Administration re: tithing issue, a conversation with your Senior Elder will be placed with you (& your spouse if applicable).
  - This will give you the opportunity to discuss your situation before any assumption is made.
- 3) **MAY** – If no change has been made in your tithing, a scheduled meeting will be placed for you (your spouse) with your appointed Senior Elder.
  - If there has been a hardship or any type of lifestyle change that plays a factor i.e. laid off, fired, hours cut, pay decreased, additional household increase etc...please notify

**4) JUNE – When the next Quarter is reviewed**

- If there has been no change or communication, you will be placed on “Rest” for an amount of time determined by your Team Leader, Overseer, and/or your Senior Elder or removed from your position as a Leader in ministry and the Assistant Team Leader will presume your role as the acting Team Leader. If no one is in place, one will be appointed.

The ministry understands that hardships can occur. If there is a financial adjustment that you and your family may have, please speak with your Senior Elder and he or she will notify the Financial Department.
